





Increasing experience in diabetes case-finding indicates that intermittent surveys and mass screening drives, although useful, have certain limitations. Getting and others,<sup>2</sup> in evaluating a community detection campaign (well publicized in the area), report that only 59% of persons accepting the free testing materials actually performed the test. Only 24% of those with positive results sought medical advice.

To find the estimated one million unknown diabetics3 and place them under needed medical care, the indispensable factor for success is the activity of the individual physician.

Graham Lusk (1866-1932) was born in Bridgeport
Connecticut and became a leader in physiological
research in the United States. He studied chemistry at
Columbia University and later received his Ph.D.
in Germany, where he worked for several years with
Carl von Voit. On his return to the United State, he
taught physiology at Yale University,
New York University and at Cornell University
Medical School in New York City.



Doctor Lusk conducted many important experiments relating to carbohydrate metabolism.

In 1912 he became the Scientific Director of the Russell Sage Institute of Pathology.

He published over 150 scientific papers and either wrote or contributed to 12 scientific books, including his most important work

"The Elements of the Science of Nutrition", which had a penetrating influence on medical research.

#### EDITORIAL SPECIFICATIONS FOR DIABETES

DIABETES is published by the American Diabetes Association, Inc., to provide an official Journal for the Association and to furnish the medical profession with information concerning diabetes and related fields of medicine. Its full title is "DIABETES—The Journal of the American Diabetes Association."

Contributions are invited from practicing physicians, clinical and laboratory investigators, and others who have data of importance to offer in this field. Manuscripts, if suitable, will be accepted provided that they are contributed exclusively to DIABETES. Papers presented at the Annual Meeting of the American Diabetes Association become the property of the Association, and the manuscripts must be submitted to the Secretary at the time of the Meeting. At the discretion of the Editorial Board they may be published in full, in part, or by abstract only. If only an abstract is used, permission may be granted on request from the authors to publish elsewhere.

Matter appearing in DIABETES is copyrighted. Permission to reproduce all or part of papers appearing in it may be granted on application, under appropriate conditions and if proper credit is given.

MANUSCRIPT SPECIFICATIONS. Manuscripts must be typewritten, double- or triple-spaced, with wide margins on standard 8½" x 11" paper. If possible, they should be submitted in duplicate.

Footnotes and bibliographies should conform to the following style:

For periodicals—Authors' last names, followed by first names or initials; complete title of article quoted from or referred to; name of periodical, abbreviated according to the list in the Quarterly Cumulative Index Medicus; volume number of periodical; complete pagination; and date (month, day of month, and year). Example:

Banting, F. G., and Best, C. H.: The internal secretion of the pancreas. J. Lab. & Clin. Med. 7:251-66, Feb. 1922.

For books—Authors' last names, followed by first names or initials; complete title of book; edition number, if any; loca-

tion of publisher, followed by publisher's name; date on title page of book; volume number, if work is in more than one volume; page number. Example:

Allen, Frederick M.: Studies Concerning Glycosuria and Diabetes. Cambridge, Harvard University Press, 1913, p. 461.

An abstract or summary of the content of the paper in not more than 250 words should usually appear at the end. If possible, this should be self-contained and understandable without reference to the text.

Photographs, drawings and figures should be suitable for reproduction purposes. Photographs should be unmounted, untrimmed glossy prints. In all instances, the names of authors should appear on the back. The top of photographs and figures should be indicated.

Galley proofs are sent to the principal author of each paper, with a price list and order blank for reprints.

All manuscripts and editorial correspondence should be addressed to the Editorial Offices, DIABETES, American Diabetes Association, Inc., II West 42nd Street, New York 36, N. Y.

Striking improvement is shown in the control of 1,281 carefully studied diabetic patients who were given NPH Iletin (Insulin, Lilly) for comparison with prior Insulin management.
